## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Degradation is rapid if a second carbon source is available to the bacteria and inorganic phosphate is present in concentrations of just a few mg/l. In pond water, biodegradation was found to take place under natural conditions without isolation and adaptation of the bacterial population. The half-life was 28 days.
